**Subject :- Providing benefit of regular pay scale to Group-“D” employee appointed on fixed pay basis.**

Sri Subharaj Debbarma, Group-D(Class-IV), Barjala Binapani H.S. School, Jirania, West Tripura has been recruited on fixed pay basis vide Memo No.F.1(1-1)-SE/E(NG)-2018 (L-2) dated 22.11.2018 against the post created on fixed pay basis keeping in abeyance of the post on regular pay scale vide No.F. 8(1-16)-SE/PLAN/2016(19) dated 03.08.2018 with the concurrence of the Finance Department, Govt. of Tripura vide U.O. No.368/Fin(Estt-III)/2018 dated 12.07.2018.

Accordingly, he has joined his duty as Group-D(Class-IV) on 15.11.2018(F/N) & completed 5 years continuous satisfactory service & eligible for regular pay scale from 15.11.2023. His name has also been entered in the data base of the Finance Department against Sl. No. 29658. Therefore, he is allowed regular Scale of pay of Rs. 16,000/- only per month plus other admissible allowance in pay level-1 as per Tripura State Civil Services (Revised Pay) (First Amendment) Rules,2018, and Memo of the Finance Department, Government of Tripura vide No. F.10(2)FIN(G)/05/Part-1 dated 16.10.2007.

The expenditure will be involved for this purpose is debit to the Head of Account against which his fixed pay is being drawn at present.

With the grant of regular scale of pay, the fixed pay post held by Sri Subharaj Debbarma shall be deemed to have been converted into regular post with regular scale of pay from the date of allowing the benefit.

If Sri Debbarma, Group-D in the meantime resigned/terminated/expired, this order should be returned to this Directorate.

If Sri Debbarma, Group-D staff has been transferred elsewhere by this time, this order may be sent to his present place of posting under intimation to this Directorate.

If, any doubt arises for taking action in the matter, it may be communicated to this Directorate for necessary step.
