The Government of Tripura vide Notification No.F.1(1)-GA (P&T)/18 dated 02-03-2019 has extended benefits for the family members of deceased Government employees who died on or after the age of 50 years, but before attaining the age of superannuation, by providing the family a special financial benefit termed as "Special Pension" amounting to the difference between last drawn pay and pension, in addition to the family pension, till the deceased employee would have attained 60 years of age, provided that there is no earning member in the family.

- 2. Smt. Nunrempuii, D/O-Lt. R. Malsawmi has prayed for "Special Pension" under this Department due to death of her mother R. Malsawmi died on 02-03-2022 while in service who was a Group-'D', Vanghmun English Medium H.S School, under I/S, Kanchanpur, North Tripura.
- 3. On scrutiny of the papers/documents/records it is seen that Lt. R. Malsawmi, Ex-Group-'D' died while in service after attaining the age of 50 years of age being her date of birth is 04-11-1968. Therefore, Smt. Nunrempuli, D/O-Lt. R. Malsawmi is entitled to get "Special Pension" under the "Scheme for Compassionate Appointment / Benefit for Government Employees of Tripura". However, an eligible family member of the family of Lt. R. Malsawmi is eligible to get "Special Pension" in addition to the family pension till the deceased employee Lt. R. Malsawmi would have attained 60 years of age as per decision of the Government.
- 4. Now, in consideration of her prayer dated 25-11-2022, Smt. Nunrempuii, D/O-Lt. R. Malsawmi "Special Pension" is granted to the family of Lt. R. Malsawmi in addition to family pension till the deceased employee Lt. R. Malsawmi would have attained 60 years of age i.e.upto.30-11-2028. The "Special Pension" will be calculated in accordance with the procedure as noted in Para-1 above.
- 5. The Inspector of Schools, Kanchanpur, North Tripura is therefore requested to arrange payment of provisional Family Pension alongwith provisional "Special Pension" to Smt. Nunrempuil, D/O-Lt. R. Malsawmi, Ex-Group-'D' and thereafter send proposals for fixation of final pension(Family Pension and Special Pension) to the Accountant General, Tripura.
