Subject:- Re-allocation of fund for Merit Grants to 1st Division in Madhyamik Examination/Re-imburement of Madhyamik Examination fee during the Financial year 2019-20 under Revenue head against SCP (Demand No. – 20).

The Finance Department (Budget Branch) Vide Memo No.F.40(03)-FIN(B)/2015/13231 dated 03/07/2019 has released a fund of ₹8,00,000/- only under **F.R. Code No.1065** being the Stipend & Scholarship (Non-Salary) during the financial year 2019-20 under Revenue Head, **against SCP (Demand No. 20).**
