2. Terms and Conditions.

- 5. The concerned teacher are directed to report to the concerned Principal/ Principal-in-Charge of the DIETs immediately being released from the concerned school.
- 6. The concerned Head of Offices & DDOs shall release the concerned teachers on 9/9/2019 positively. They are also requested to paste the undertaking given by them in their respective service book.
