Subject:- Allowing of benefit of financial up-gradation under **Modified Assured Career Progression Scheme (MACP)** as per TSCS (RP) Rules, 2017.

Pursuant to the provision of the Rule-12 of the Tripura State Civil Services (Revised pay) Rules, 2017 the Headmaster/Headmistress as mentioned in the 'Annexure' enclosed herewith are allowed admissible benefit of second financial up-gradation as **MACP-2** on completion of 17 years of service in the said post from the date mentioned in col. 2.
