MEMORANDUM

Subject: - Modification of guidelines for implementation "Super 30" Scheme.

With the approval of the competent authority vide **UO No. 1561/Cell/ DSE,** dated, **RB**, 27/05/2022, the guidelines of Super 30 Scheme as per Memo No. F.13(5-37) / SE / GL-I/ 2020 is modified as follows:

1. The Scheme

Top 30 (Thirty) willing students of Government and Government-Aided School of Tripura in science stream with proportionate reservation quota for ST/SC as per State Reservation policy, including one reserved seat for Specially abled candidate will be sponsored to different leading coaching institutes as per choice of the students to prepare themselves for JEE/NEET entrance examinations.

2. Eligibility Criteria

- Class-X Board Final Examination passed out Top 30 students from Govt. and Govt. aided Schools of Tripura in order of rank in the final merit list of "Super 30, Joint Selection Test" maintaining 100-point roster.
- ii. Total family income from all sources should be below 8.00 Lakh per annum. As such, if the annual income of the family is less than 8.00 Lakh per annum, the family is in non-creamy layer category.

3. Selection Procedure

i. Top 30 students will be selected through a Joint Selection Test. All the Class-X Board Final Examination appearing students of Govt. & Govt.-aided Schools from all categories are eligible to appear in the said Selection Test. Syllabus for the test will be based on Class- X standard NCERT syllabus. As per ranking in the Selection Test, a list of 30 students from ST category, 20 students from SC category, 03 Students from PH category and 50 Students from UR category will be published. All together 30 (thirty) top ranking students will be given the opportunity and the rest will be kept in the waiting list. If any of the top 30 students is not willing to accept the offer given by the State Government, the offer will be given to the students from waiting list maintaining the criteria to fulfil the target.

- The stipulated quota of 30 students will be fulfilled continuing the process of selection until the required number is attained according to the merit list of the Selection Test.
- iii. The selected top 30 students will be given a chance to choose their course and nationally reputed coaching institutes in any State within the country.
- iv. If situation arises in the process of selection that more than one student of the same social category has secured the same rank with same marks, then the marks obtained in Science Group (Science & Mathematics) in Class-X Board Final Exam will be considered. If even after that, marks of students match with each other than drawing of lottery under strict supervision will be followed to select a student from the same rank.

5. How to apply

Notification and Information regarding Super 30 Joint Selection Test will be published through DSE website and as advertisement in newspapers (at least in 03 leading local newspapers) by the Directorate of Secondary Education before the publication of the Class-X Board Exam. result for wide publicity and information of all the stakeholders. Eligible students will be able to apply for their candidature online through link provided by DSE. Time to time information including the result of the Selection Test as per merit, call to attend counselling program in due date etc. will be available in the DSE official website. https://schooleducation.tripura.gov.in/

The following documents are to be Submitted while counselling: -

- i. Mark Sheet of Class-X Board Final Examination (Photocopy).
- ii. Admit Card of Super 30 Selection Test Exam. (Photocopy).
- iii. Aadhaar Card of the student (Photocopy).
- iv. Caste Certificate (Photocopy).
- v. Income Certificate of Parents (Original).

They will then be invited to attend counselling session to avail this financial support. They will have to secure admission in reputed and established coaching institutions outside the state:

6. Function of Secondary Education, Tripura

On receipt of the applications, the Directorate of Secondary Education will select the top 30 students on the basis of the result of Selection Test via Counselling Program as per guidelines mentioned in the selection procedure. The fund will be provided directly to the Coaching Institutes in 02 (Two) instalments. The students / parents will inform the Directorate of Secondary Education about their choice of coaching Institution with details well ahead in black and white. Bank detail of the coaching institution where the student is taking/ has taken admission has to be submitted to the Directorate of Secondary Education to smoothen the process of admission. Fund will be transferred to the Coaching Institutions only

after getting confirmation of admission with documentary evidence. An undertaking will be taken from the parents that student is staying outside Tripura for the purpose of availing coaching facilities.

7. Financial Assistance by the State Government

- i. For accommodation fee and course fee, the expenditure will be 1.40 lakh and Rs.1.00 lakh respectively. In total Rs. 2.40 lakh (Rs.1.40 lakh + Rs.1.00 lakh) per year per student will be required. Therefore, total financial involvement of the State Govt. per year will be Rs.2.40 lakh X 30 = Rs.72.00 lakh.
- ii. From the subsequent years, the amount will be twice i.e. Rs.144.00 lakh per year. Because, in the starting year, 30 (Thirty) students will be enrolled in class XI, but, from the next year these students will be promoted to class XII and new batch of another 30 (Thirty) students will take admission in class XI.
- iii. It is also expected that fees and other expenses may increase by 5% and taking that into consideration, the total financial involvement in the 2nd year may be 151.2 Lakh (144 Lakh + 5% of 144 Lakh). Similarly, 5% increase of the total amount is expected every year.
- iv. Any extra expenditure involved will not be borne by the Secondary Education.

8. Monitoring Process

- Mentor Teachers will be selected later from the DSE, Tripura. They will be chosen
 to supervise the process. They will keep in constant touch with them to monitor
 their seriousness, progress etc.
- ii. If at any time, it is felt that any student is losing interest in preparation/ not serious as per report of the mentor/ or has not secured admission to a permanent branch of a top-notch coaching institute, the department would discontinue its assistance to the student.
- iii. A sub-committee constituted by the Department under the Director; Secondary Education would quarterly review the progress as per report of Mentors/ Scores of Coaching Institutes. Detailed guidelines will be issued by the department from time to time.
- iv. If any student becomes unsuccessful in the first attempt and decides to appear as repeater, the additional expenditure of the coaching centre will have to be borne by the parents/ guardians of the respective students.

9. Terms & Conditions

This entire scheme is subject to modification by the Govt. of Tripura at any time.
