

2. This benefit of financial up-gradation is allowed subject to final verification by the A.G Tripura.

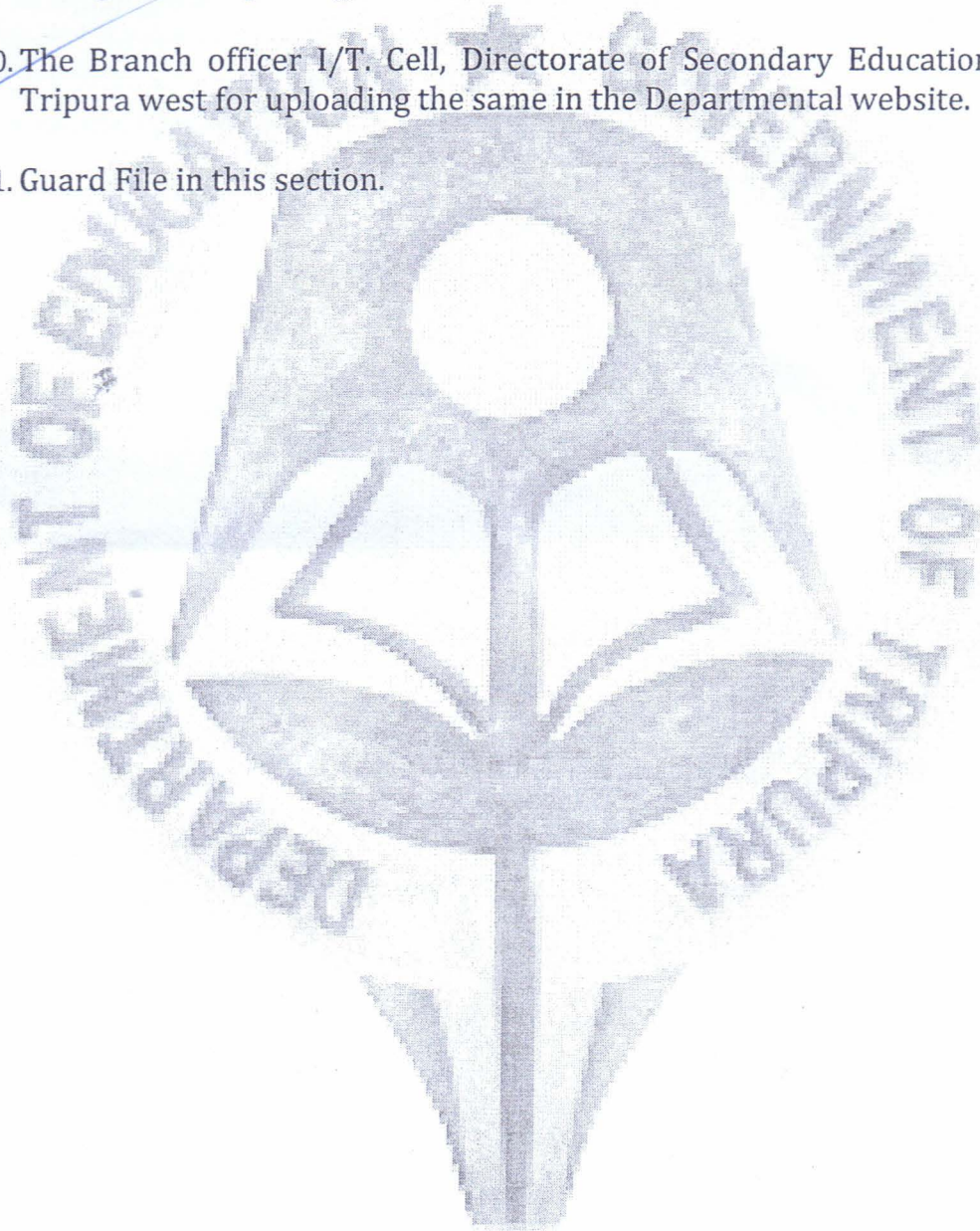
